HONESTY

This should go without saying in any job, but we list it first because our number one requirement in dealing with Guests, other employees and the company. This is our #1 priority on reference checks. Honesty in our business means accurate cash handling, proper use of equipment and inventory controls. This also means that your friends and family do not receive free food, or attractions, just as you would not expect free gas from a friend that works at a gas station.

DRUGS & ALCOHOL

Every crew member has daily contact with our guests. We feel that the use of drugs or alcohol is not conductive to good employer/crew member or crew member/guest relations. For this reason, we have a random drug testing program at our location. By signing this application you agree to participate in this program. For your safety of fellow crew members and our guests, we want to have a drug free work place and will do whatever it takes to achieve this goal. If you have a specific question about the drug policy, ask a manager. Coming to work under the influence of drugs or alcohol, or the use of drugs or alcohol in any manner while on duty is strictly forbidden and will result in immediate termination.

SCHEDULE

We expect you to work the days you are scheduled and to be on time! Tardiness and absentee-ism will not be tolerated or accepted. You should expect, due to the nature of our business, to work evenings, weekends and holiday periods. We are open 361 days a year, we are closed for Christmas Eve, Christmas day, New Years Eve and New Years day.

APPEARANCE

All employees are required to wear the proper uniform. This includes the shirt which we provide, and the proper shoes, socks, and pants that you will provide. Employees are not allowed to have extreme hairstyles or colors and/or visible tattoos or body piercings. Male employees are not allowed ear piercings. Female employees are allowed one earring per ear.

Every Fun Center Employee has daily contact with Guests. Good people skills and courtesy at all times are required. If you enjoy dealing with people, this is the job for you.
